TERMS & CONDITIONS • SIGNATURES

1. ENTIRE AGREEMENT: This agreement contains the entire understanding between "Sweet Beginnings" and the "Client(s)". It supersedes all prior and simultaneous agreements between parties. The only way to change or add to this agreement is to do so in writing, and providing the document in signed by all relevant parties.
2. RESERVATIONS AND PAYMENTS: Upon the "Client(s)" signature, Sweet Beginnings will reserved the event rentals agreed upon and will not rent out to another client. For this reason, the non-refundable retainer fee of _____ is non-refundable, even if the date is changed or the wedding is cancelled for any reason: including Acts of God/Force Mejeure. The non-refundable retainer fee is to be paid at the time of signing the agreement. The non-refundable retainer fee is applied towards the contracted even rentals total. "Client(s)" understands and agrees that the entire amount owed for the event rentals described in the agreement is due 14 days prior to the wedding date.
3. MISSING OR DAMAGED ITEMS: "Client(s)" resume responsibility for missing or damaged rental items and agrees to pay replacement cost following a detailed invoice presented by Sweet Beginnings.
4. CANCELLATION: In the event that "Client(s)" cancel the contracted services for the event rentals outlined in this agreement less than 14 days prior to the wedding date, all fees will be forfeited by the "Client(s)". If the "Client(s)" cancels the contracted services for the event rentals outlined in this agreement more than 14 days prior to the wedding date, the deposit will be forfeited.
5. TRAVEL/CLEANING FEES: Travel fees may be applied for all events outside Lompoc and surrounding areas. A travel fee of \$ _____ will be included in the agreement. "Client(s)" are not responsible for cleaning rental items. For this reason a cleaning fee of \$ _____ will be applied when applicable.
